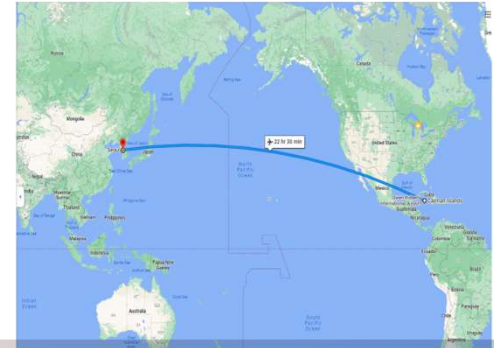

Cayman Islands Intellectual property regime

- Copyright and patent laws are currently an extension of the UK copyright and patent laws but modernized Cayman legislation is in the pipeline
- Cayman has its own trademark legislation (Trademark Act 2016)
- Cayman law provides for both civil and criminal penalties for infringement

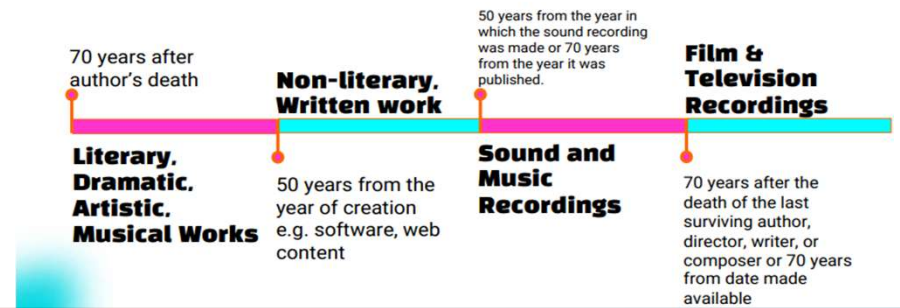


Copyright Protection - Scope

- Over 181 countries pursuant to the Berne Convention for the Protection of Literary and Artistic Works

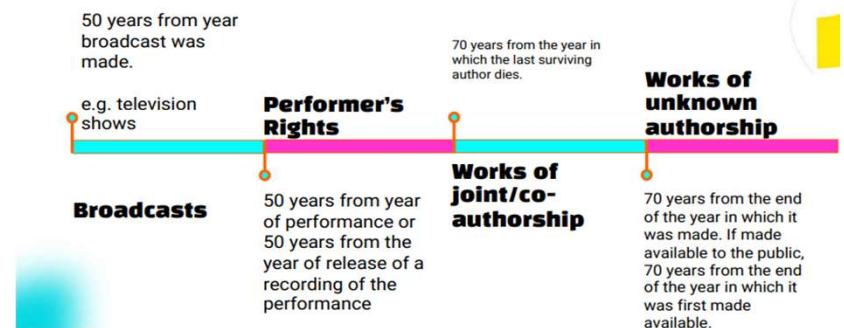
- Reciprocal rights / Neighbouring rights
